- Implemented a new billing and collections process over the course of a year that dropped our percentage of receivables uncollected over 90 & 120 days from 18% in June of 2015 to our company record low of 3% in June of 2016 on over \$14 Million in receivables.
- Responsible for all end of the month close processes on the revenue side including accruals, journal entries and write ups/financial statement analysis for Senior Management.
- Manage and audit internal profit and loss “trucking” reports weekly from 7 of our branches to identify more profitable routes for our drivers as well as making sure our billing information is in compliance with all of our contracts.

- Traveled to our primary 3 branches (San Angelo, Carrizo, and Kenedy) weekly managing all the revenue and making sure it was accurate and invoiced in a timely manner within our customer’s guidelines.
- Worked hand and hand with the Procurement division and helped setup the PO process that is used to this day.
